INSTALLATION TIPS

Refer to Installation, Operation & Maintenance Manual for cartridge flushing and start-up

OPERATION TIPS

Change cartridges on a regular six (6) month preventative maintenance program

Change cartridges when capacity is reached or when pressure decreases

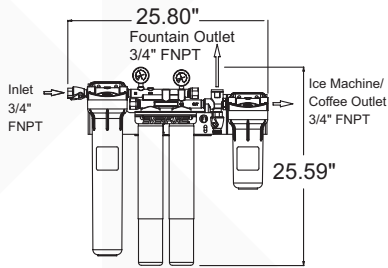

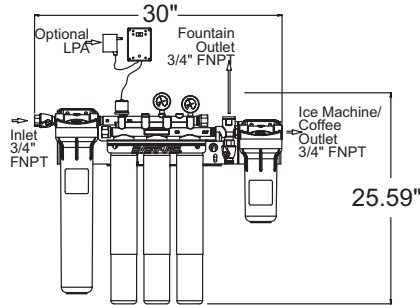

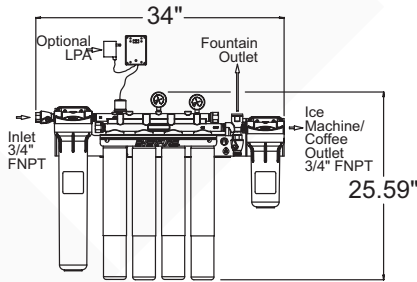
